New Codes - COVID-19

WCIO now has new Nature & Cause of Injury Codes for the COVID-19 Pandemic. A new Cause of Injury Code (DN0037) - 83 for "Pandemic" and a new Nature of Injury Code (DN0035) - 83 for "COVID-19" were approved. The Commission began accepting the codes on April 1, 2020 as requested by the IAIABC.

During this project, all Trading Partners will be contacted by a member the EDI QA team requesting them to review the current information and provide updates as necessary. After the updates are completed for this year, this process will become annual occurrence that will happen around July of every year.

Larger Than Normal Volume

If your organization is planning to submit a larger than normal volume of transactions in a single day or over a period of time, we ask that you please provide the VWC with advance notice if possible. The following are example scenarios:

- Large Acquisition requiring AQs on all open and active JCNs
- Company merger
- Global name or address change for an employer
